Course Description:

Theatre Operations will provide students with an overview of the administrative and management functions of a nonprofit theatre company. Through readings, field experiences, discussions, research projects, and field trips students will develop an understanding of the structure and business of the theatre. Topics to be covered include the history and current practices of outreach, development, marketing, arts education, event planning, and arts policy. Through projects and work assignments in arts management, students are asked to explore “why” the arts are important to society and “how” they can use their skills as young arts managers to serve the community.

Course Objectives:

1. To encourage a deeper understanding of the arts industry so students can play a meaningful role in the arts now and in the future as patrons, artists, and arts managers.
2. To expose students to career choices in arts management.
3. To develop leadership and community responsibility through practical experiences at Duke Ellington and arts organizations throughout the city.
4. To encourage a greater appreciation and respect for the work that occurs behind the scenes.

Course Requirements and Rules:

1. All classes are mandatory. Exercises, discussions, and performance work cannot be made up for the simple reason that they happen in class.
2. Don't be late! Tardiness is an unacceptable practice in this business and will severely affect your final grade.
3. All written assignments must be typed. Use a 1 inch margin and 12 point font. Staple papers that are more than one page.
4. Students are responsible for making up all work missed during an absence by the next class. It is the students' responsibility to get the work from the teacher during absences.
5. Late work will be accepted for half credit the day after an assignment is due. Work more

than one day late will not be accepted.

6. It is the student's responsibility to ask the instructor about grades when needed.
7. Students are required to schedule and attend rehearsals and meetings when necessary.
8. Students are required to change into their theatre uniform at lunch. Students not dressed will receive an "F" for their work that day. For more information about the departmental dress code, see the Theatre Handbook.
9. Bring a journal, notebook and pen/pencil to every class.
10. Any student caught cheating on or plagiarizing will receive a failing grade for that assignment. Plagiarism includes pirating information from the Internet without proper documentation.

Class Environment:

Due to the nature and content of this course the student must understand that s/he will be required to work with classmates to complete papers, projects, presentations, and special events. Learning to collaborate with others is as important while managing the arts as it is while performing the arts. You will work closely with others in the class, which may create conflict but learning to resolve disagreements with people is a challenge that arts managers regularly face from artists, government agencies, and the public. If a problem occurs within the group that cannot be resolved, please do not hesitate to talk to the instructor.

Students will receive grades for the following:

1. Practice and Application 50% (warm-ups, in-class discussion, improvisations, exercises, movement sequences, attendance, focus, work-ethic)
2. Assessments 40% (scene work, reflective papers, exams, juries, group projects, performances, compositions)
3. Participation/Citizenship 10% (leadership within the department: behavior in hallway and class, participation in activities like theatre fund raisers and events, volunteer project, ensemble job responsibility)
